Through Dynamic Currency Conversion (DCC), our merchants can offer foreign customers the world-class experience of paying in their home currency—available both in-person and online at no extra cost.

Payment Experience Without DCC

Without Dynamic Currency Conversion (DCC), international cardholders are forced to pay in local currency, creating a lack of visibility into the true cost of their purchase in their home currency at the time of payment.

Issues with this Process

Exchange Rate Volatility: The final charged amount is subject to the card network's or issuing bank's exchange rate applied days later.

This rate is often unfavourable and may fluctuate between the time of payment and the time the transaction is settled.

Hidden Costs: Without DCC, the consumer lacks visibility into the fees charged by their bank.

Delayed Clarity: The cardholder only discovers the final cost when their bank statement arrives days later.

Introducing Dynamic Currency Conversion with TJ

When a merchant activates DCC and an international card is presented for payment, the system automatically recognises the card as foreign.

Once recognised, the transaction amount is converted into the home currency based on the exchange rate at the exact time of sale, and displayed on the payment terminal or the online payment page. Any applicable fees are added to the total amount directly.

The cardholder is then presented with the option to pay in either the local or their home currency. By choosing to pay in their home currency, cardholders lock in the exact exchange rate and final payment price at the time of the purchase.

This sophisticated infrastructure ensures they know exactly what they will be billed, with no hidden fees. DCC is the global standard that builds trust and makes a sale more likely.

The DCC Transaction Steps

01

Transaction Initiated

The payment request is initiated as usual from the point of sale or the online store.

02

International Card Recognition

Customer presents an international card for payment and the system identifies the card as foreign.

03

Real-Time Currency Conversion

The DCC system presents a real-time conversion into the customer's native currency, with any applicable fees included in the amount.

04

Local or Home Currency Choice

Customer selects to pay in their chosen currency.

05

Secure Authentication

The transaction proceeds with standard PIN or authentication protocols.

06

Transparent Confirmation

The final receipt and confirmation include full details of the transaction currency, exchange rate, transaction margin, and final transaction amount.

07

Settlement and Reconciliation

For the merchant, DCC transactions are settled and reconciled based on the local currency amount, with additional indicators to show it was a DCC transaction.

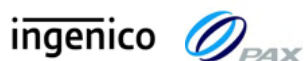

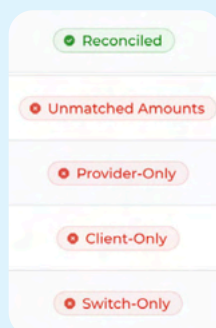

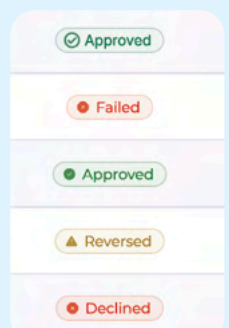
